REPORTING AN ICE SIGHTING

Call: 1-844-864-8341

- Dial 1 to speak with a dispatcher immediately
- Dial 2 to report a past event
 - Provide your phone number and the name of your town

WHAT WILL THEY DO?

The dispatcher will ask for detailed information about the location and situation.

Trained volunteers will be sent to the scene to:

- Record the event.
- Identify participating ICE agents.
- Remind those involved of their constitutional rights.

COLORADO IMMIGRATION AND DEPORTATION LAWS

Courthouses:

- ICE cannot make arrests in or around courthouses or when someone is on their way to or from court
- Probation officers are prohibited from sharing information with ICE

Individuals in Jail

- You must be informed of your right to refuse an interview with ICE while in jail
- If you post bond for someone who is then deported, you are entitled to a full refund

Anti-Extortion and Coercion Protections:

- It is illegal to threaten to report someone's immigration status to force them to pay money, do something illegal, or prevent them from reporting a crime

Limits on Collaboration with ICE:

- Police departments cannot hold someone for ICE beyond their scheduled release date and police cannot arrest someone based solely on their immigration status.
- IGSA contracts (allowing local jails to rent beds to ICE for detention) are prohibited.

Protection of Personal Information:

- State agencies cannot share personal identifying information with ICE unless ICE provides a warrant or subpoena.
- Third-party entities can only access state databases if they sign an agreement not to share information with ICE.
- State agencies can only collect immigration status when required by state or federal law.

WHY SHOULD YOU REPORT SIGHTINGS?

- **Monitor ICE Activity:** Reports help detect patterns of collaboration between ICE and local law enforcement.
- **Strengthen Advocacy:** Testimonies from directly impacted individuals shape legislative efforts, such as Colorado's successful repeal of the "show me your papers" law in 2013.
- **Empower Communities:** Build a statewide network to resist deportations and protect families.

NATIONAL LAWS

The 4th Amendment protects you from Unlawful searches: Say:

- "I do not give you my permission to enter my home, based on my 4th amendment rights under the United States Constitution."
- "I will only permit you to search my home if you show me a search warrant signed by a judge. If you have such a warrant, please tell me and slide it under the door."

The 5th Amendment is the right to remain silent: Say:

- "I do not wish to speak with you or answer your questions, based on my 5th amendment rights under the United States Constitution"

The 6th Amendment is the right counsel. Say:

- You have the RIGHT to seek legal advice, and the RIGHT to a trial!

How to Update Emergency Contacts in Infinite Campus



UPDATE THE STUDENT'S EMERGENCY CONTACT INFORMATION

Provide alternative contacts for your child in Infinite Campus in case a parent/guardian is not available.

MAKE CHILDCARE ARRANGEMENTS

Designate a trusted adult to care for your child(ren).

Discuss this plan in detail with your child(ren) and seek counsel from a legal organization on legal guardianship.

POWER OF ATTORNEY

A power of attorney is a legal document that grants rights and powers to someone you trust to handle certain matters for you. These matters can include managing finances, handling medical care, caring for minor children, or addressing other specific needs.

ORGANIZE IMPORTANT DOCUMENTS

Families and students should know where to find important documentation, such as birth certificates, passports, ID cards, doctors' contact information, medication lists, and lists of allergies.
